RULES

- There will be two rounds. The first round will consist of all acts. Some contestant will advance to the finals, however others will not. An intermission will take place in between the rounds.
- The talent show is open to any age.
- Talent may include (but not limited to) singing, dancing, instrumental, music, skits, magic, comedy, martial arts, juggling, No lip-synching.
- Recommended length is 3 minutes; acts must be no more than 5 minutes.
- Maximum number of participants in an act is 8.
- In all cases, decisions of the judges are final and will not be open to discussion. Score sheets are the property of Adams County Agricultural Society and will not be released to participants.
- Absolutely no profanity or insensitive subject matter will be permitted.
- Costumes must be appropriate for all age groups. This is a community event.
- Acts are responsible for their own props and costumes. There will be no set up time and no sound checks. Standard music bands with drums, guitar amps, keyboards, etc. are not permitted to compete due to the time it takes for set up.
- If you act requires recorded accompanying music, the music must be provided to the Talent Show Committee before the performance. If using a CD must be labeled with your name, the name of your song, and the number of the track.
- It is the participant's responsibility to get the accompanying music back after the show.
- Acts with any member under 18 must have a written consent from parents.
- Prizes are as follows 1st - \$500.00, 2nd - \$400.00, 3rd - \$300.00, 4th - \$200.00, and 5th - \$100.00.
- **All participants MUST turn in a properly completed entry form and fee of \$25.00 (does not include admission to fair). Entry Forms can be sent to Adams County Ag Society, P.O. 548, West Union, Ohio 45693 by July 8th or be turned into the day of the competition.**
- A panel of three judges will score performances based on the following: 1. Stage Presence and Appearance; Technical Correctness, Timing, and Volume; Crowd Appeal; and Overall Quality and Talent Ability.
- Disqualification: The committee reserves the right to disqualify and/or exclude any individual from the competition if any rules and regulations are not met. We also reserve the right to change the rules and procedures at any time if circumstances require us to do so. Participants will also be disqualified if any incorrect information is provided during the application process or if during the performance it is deemed a non-family performance.
- General Conditions: By participating, contestants agree to the terms and conditions of the contest and understand that all judging is final and binding.
- We reserve the right to use your name, pictures, audio or video recordings for publicity and other purposes without compensation. All federal, state, and local laws apply. All participants and legal guardians agree to not pursue any legal claims against the Adams County Fair, event sponsors, organizers and/ or anyone associated with this event.
